Durham Expands Targeted Brownfield Assessment Activities

City Hosts Public Meeting Highlighting EPA Brownfield Grant Expansion

Fast Facts

- In 2014, the City of Durham received a dual three-year EPA Brownfield petroleum and hazardous substances assessment grant totaling \$399,999 to expand Phase I and Phase II environmental assessment and related activities throughout Durham. Brownfield sites are those where expansion, redevelopment or reuse of underutilized property may be complicated by the potential presence of hazardous substances, environmental pollutants or contaminants.
- The 2014-2017 grants provide a vital economic development finance tool designated specifically for community outreach and redevelopment planning activities associated with

completion of Phase I and Phase II environmental assessments at targeted redevelopment project sites. Funds may be used to investigate potential brownfield sites located citywide, with an emphasis on properties located in Northeast Central Durham.

- Community involvement is an integral part of every targeted brownfield grant and is a key factor in the EPA's evaluation of each grant project. Therefore, public and community-based organizations, property owners and developers are encouraged to attend the March 10 public meeting to become better informed about the planned project schedule and proposed assessment activities.
- The current award is the third EPA grant the City has received for brownfield environmental assessment activities in recent years. From 2006 to 2012, the City successfully administered similar EPA brownfield assessment grants in accordance with the Northeast Central Durham Strategic Revitalization Plan. Past Brownfield activities included community participation, site inventory, and Phase I and Phase II environmental assessments where known or perceived environmental contamination complicated proposed redevelopment activities.
