## DCHC MPO Seeks Public Comment on Transportation Priorities

*April 1 Deadline to Complete Online Survey; Workshop & Public Hearing Set for March*

DURHAM, N.C. – The [Durham-Chapel Hill-Carrboro Metropolitan Planning Organization \(DCHC MPO\)](#) is seeking public feedback on the draft goals and objectives for its 2045 Metropolitan Transportation Plan, which will drive future policies and decision-making processes for highway, bicycle, pedestrian, and transit projects.

Residents and stakeholders can now review and provide input on the draft goals, objectives, and performance measures using a variety of methods:

- Attend a public hearing with local elected officials on Wednesday, March 9 at 9 a.m. in the Durham City Hall Committee Room, located at 101 City Hall Plaza.
- Attend a drop-in public workshop on Thursday, March 17 between 4 p.m. and 7 p.m. at the Durham Station Transportation Center, located at 515 W. Pettigrew Street.
