2016 Durham Golden Leaf Award Winners Honored

Community Awards Recognize Best Contributions to Durham's Appearance

DURHAM, N.C. – Last night, nine projects were honored for excellence in design and preservation of their properties during the [2016 Durham Golden Leaf Awards for Community Appearance](#).

The awards program, sponsored by the Durham City-County Appearance Commission, Keep Durham Beautiful, Inc., and the Durham City-County Environmental Affairs Board, honors excellence in design, preservation, and stewardship of the natural and built environment.

This year, 24 entries in the following seven categories were received: Keep Durham Beautiful; Neighborhood Garden & Landscape; Hearth & Home; Adaptive Reuse, Old Building – New Design; Small-Scale Development; Large-Scale Development; and Sustainable Design. In addition, there were also two People's Choice winners.

The winners honored during last night's event, held at the Durham County Government Administrative Complex Commissioners' Chambers, are as follows:

Judging of the awards, except for the People's Choice Award, was done by an independent panel of local professionals representing architecture, landscape architecture, development, and the arts community.

Selection criteria included excellence in design of a new development and/or improvement of an existing structure; raising community awareness of the value of good design and stewardship; improving the character, environment, or livability of an area; and a commitment to ongoing property maintenance in landscaping.

The People's Choice Awards were selected by public vote from the nominees under consideration for any of the award categories for 2016. With voting open from March 15 to April 1, over 4,500 votes were cast for this award category.
