

## Public Hearings and Notices – Sept 17 2018

The Durham City Council will hold a public hearing on **September 17, 2018**, at 7 p.m. in the City Council Chambers, 1st Floor, 101 City Hall Plaza, to hear the following requests:

### Street Closing

**Christian Avenue (SC1600008)** To permanently close a 0.781 acre (approximately 331 linear foot) portion of public right-of-way of Christian Avenue, north of Hillsborough Road, west of Wortham Street.

**Case Street II (SC1800007)** To permanently close a 330.08 linear foot portion of public right-of-way at south of West Pettigrew Street, east of Erwin Road, and west of Swift Avenue.

### Annexation Petition

**SRLS Annexation (BDG1800006)** A request for a voluntary annexation for a 26.88 acre parcel located at 4780 Kemp Road.

**Salix Drive (BDG1700018)** A voluntary annexation petition to annex a contiguous 6.57 acre tract located generally at 426 Scott King Road.

**AAA Storage (BDG1800003)** A voluntary annexation petition to annex a contiguous 7.13 acre tract located at 750 and 804 Junction Road.

### Zoning Map Change

**AAA Storage (Z1800003)** is a request to change the zoning designation of property located at 750 and 804 Junction Road from Industrial Light and Residential Suburban-20 (RS-20) to Industrial Light with a Development Plan (IL(D)).

**Salix Drive (Z1700054)** is a request to change the zoning designation of property located generally located at 426 Scott King Road from Residential Rural (RR) to Residential Suburban-20 (RS-20).
