

# Durham Stay-at-Home Order: What's Different?

## May 22, 2020



On Friday, May 22, 2020, at 5 p.m., Durham's updated Stay-at-Home Orders are in effect until rescinded. While mostly adopting Governor Roy Cooper's statewide Executive Order 141, there are some more stringent requirements for Durham residents and visitors. <b>Commercial Activity</b>	People can leave home for commercial activity; more businesses open (essential & non-essential designations removed)	People can leave home for commercial activity; more businesses open (essential & non-essential designations removed)
<b>Retail</b>	50% capacity allowed with cleaning & disinfecting	50% capacity allowed with cleaning & disinfecting
<b>Mass Gatherings (Meeting &amp; event venues, amphitheaters, sporting venues &amp; arenas, groups at beaches/parks)</b>	10-person limit indoors; 25-person limit outdoors	No indoor mass gatherings allowed with non-household members; 10-person limit with non-household members outdoors with social distancing & sanitation required
<b>Religious Worship Services, Weddings &amp; Funerals</b>	Indoor and outdoor services allowed with no person-limit restrictions; social distancing & sanitation encouraged	Indoor and outdoor services allowed with no person-limit restrictions; social distancing & sanitation required
<b>Childcare</b>	Open; must follow DHHS guidelines	Open; must follow DHHS guidelines
<b>Teleworking</b>	Encouraged	Encouraged
<b>Restaurants</b>	50% capacity and other requirements	Closed except for curbside takeout/carryout until June 1 at 8 a.m.
<b>Barbers, Salons &amp; Personal Care</b>	50% capacity and other requirements	Closed until June 1 at 8 a.m.
<b>Pools</b>	50% capacity and other requirements	DPR indoor & outdoor pools closed; private pools closed until June 1 at 8 a.m.
<b>Parks, Trails &amp; Greenways</b>	Open	Open
<b>Face Coverings</b>	Encouraged	Required
<b>Summer Camps (Day &amp; Overnight)</b>	Allowed	DPR summer camps closed until further notice; private camps closed until June 1 at 8 a.m. & must follow DHHS guidelines
<b>Sports/Recreational Activities</b>	Allowed with social distancing	Allowed with social distancing
<b>Real Estate</b>	N/A	Modifications made to permit showings of occupied dwellings; restrictions remain
<b>Bars/Nightclubs</b>	Closed	Closed
<b>Indoor Entertainment Venues (Movies, Bowling, Bingo, etc.)</b>	Closed	Closed
<b>Gyms &amp; Fitness Studios (yoga, cycling, martial arts, etc.)</b>	Closed	Closed
<b>Playgrounds</b>	Closed	Closed
<b>Museums</b>	Closed	Closed
<b>Visitation at Long-Term Care Centers</b>	Not Allowed	Not Allowed
